2. Heard the learned counsel for the petitioner and the learned counsel for the respondent.

3. According to the petitioner/wife, she is now living with her parents at Salem and the distance between Salem and Coimbatore is 165 kilometers. It is further stated that she is having a minor daughter and finds difficulty to travel from Salem to Coimbatore to attend each and every Court hearings and therefore, the instant petition has been filed.

4. It is settled law that in cases involving matrimonial dispute, the preference shall be given to the convenience of the petitioner/wife.

5. By taking into consideration the inconvenience expressed by the petitioner/wife in undertaking a travel to Coimbatore, this Court is inclined to allow the above transfer petition as prayed for.

No costs. Consequently, connected miscellaneous petitions are closed.
