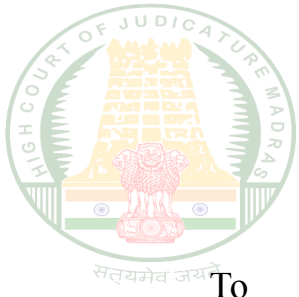
4. The writ petition stands disposed of accordingly. There will be no order as to costs. Consequently, connected miscellaneous petition is closed.
