WEB COPY This Criminal Original Petition has been filed seeking direction to direct the respondent to file a charge sheet in Crime No.772 of 2024 before the concerned Magistrate within a specified time frame.

2. Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Crl.Side) appearing for the respondent-Police and perused the materials available on record.

The learned counsel for the petitioner submitted that the petitioner lodged a complaint as against the accused persons before the respondent-Police on 20.10.2024 and the same was registered in Crime No.772 of 2024 for the offences under Sections 191(2), 329(1) and 126(2) of BNS 2023. The respondent-Police has neither completed the investigation nor filed a charge sheet before the Magistrate concerned so far. Hence, the petitioner is constrained to file this criminal original petition.
