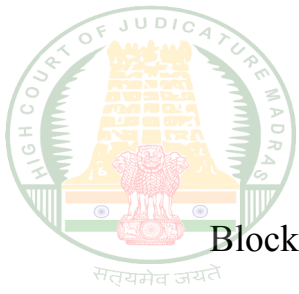

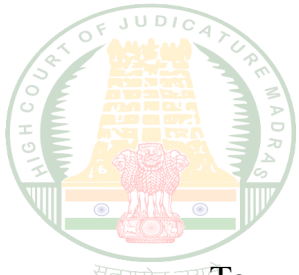
The learned counsel for the petitioner seeks permission of this Court to withdraw this petition and he has also made an endorsement to that effect in the Court bundle.
