The petitioner seeks a direction for the payment of additional security deposit of Rs.77,44,987/- in six equal installments along with the regular current consumption charges.

The first installment shall be paid on or before 17.06.2025 and the subsequent installments shall be paid on or before the first of each succeeding month over the next five
