Prayer: Writ Petition is filed under Article 226 of Constitution of India, to issue Writ of declaration, declaring the decision taken by the Finance Committee dated 18.01.2017 and Syndicate in Resolution No.41 dated 08.02.2017 insofar as refixing the Scale of Pay in the pay band of Rs.9,300 – 34,800 + GP 4,600 from 15,600-39,100 + GP 5400 and the consequential



notice issued by the third respondent bearing Reference No.C1-10/21851/2018 dated 13.08.2018 as illegal contrary to the statutory protection given under Sec. 58 (3) (e) of the Annamalai University Act, 1913 and direct the respondents to continuously pay the salary as being paid as on date with 7th Pay Commission benefits from the due date and pass orders.
