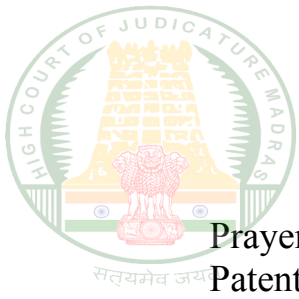

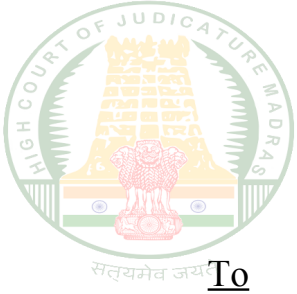
COMMON JUDGMENT
