2. When the matter is taken up for hearing, the learned Special Government Pleader appearing for the respondents submitted that notwithstanding their objection they are willing to appoint fresh enquiry officer.

3. Recording the said submission made by the learned Special Government Pleader the impugned order passed by the 1st respondent in C.No.B2/8810485/2024 dated 27.05.2025 is ordered to be quashed and the respondents are directed to appoint fresh enquiry officer within a period of two weeks from the date of receipt of a copy of this order and directed to proceed with the enquiry in accordance with law. The petitioner is also directed to cooperate for the enquiry.

4. With the above direction, the writ petition is disposed of. No costs. Consequently, connected miscellaneous petitions are also closed.
