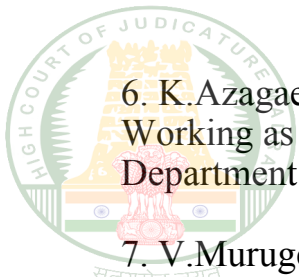

2. In view of the same, the Writ Petition is dismissed as withdrawn. Consequently, the connected Miscellaneous Petition IS closed. No costs.

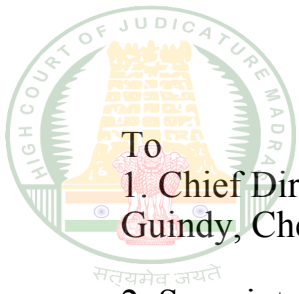
