This Criminal Original Petition has been filed to transfer the investigation in Cr.No.144 of 2021 pending on the file of third respondent to the file of the second respondent or to other investigation agency.

The learned Government Advocate (Crl.side) appearing for the respondents submitted that after securing the first accused, the investigation in Crime No.144 of 2021 has been completed and filed a final report before the CCB and CBCID Court, Egmore, Chennai. 4. If there is any grievance over the final report filed by the Investigating Officer with regard to not adding the accused and not adding the
