It is stated by the learned counsel for the petitioner that though this writ petition has been filed seeking for a direction to transfer the investigation, the investigation is already completed, final report is laid in S.C.No.173 of 2021 on the file of the learned Principal District and Sessions Judge at Chegalpattu. The said final report is also quashed by this Court in CrI.O.P.No.5571 of 2023 vide order dated 27.03.2025. Hence, it is submitted that nothing survives in this writ petition as the very final report itself is quashed.
