This Writ Petition is filed for a Writ of Mandamus, directing the respondent herein to receive the application of the petitioner dated 07.05.2025 in Form CCPA along with the prescribed fee through online for the grant of Auto Rickshaw Permit to operate the vehicle within a radius of 30 Kms distance from Salem Town Old Bus Stand, Salem, Salem District.

2. In an identical case, this Court, in the case of **A.Rajavel vs. The Regional Transport Officer, Salem East, Salem District** **[W.P.No.13551 of 2025]** decided on 16.04.2025, passed the following order:

“9. In view of the above ration laid down by this Court in W.P.Nos.14300 to 14305 of 2024, the respondent is directed to receive the application of the petitioner dated 17.03.2025 in Form CCPA along with the prescribed fee through online for the grant of an Auto Rickshaw Permit to operate the vehicle within a radius of 30 Km distance from Salem Town Old Bus Stand, Salem District, and pass appropriate orders on its merits, in accordance with law, within a period of eight (8) weeks from the date of receipt of a copy of this order.”

3. The issue raised in this case is similar to the one already decided in the aforementioned W.P.No.13551 of 2025. Hence, the present ***Writ Petition is disposed of*** with a direction to the respondent to receive the

petitioner's application dated 07.05.2025 in Form CCPA along with the prescribed fee through online for the grant of an Auto Rickshaw Permit to operate the vehicle within a radius of 30 KMs distance from Salem Town Old Bus Stand, Salem District, and pass appropriate orders on merits and in accordance with law, within a period of eight (8) weeks from the date of receipt of a copy of this order. No costs.
