COMMON ORDER

(1) CMP.Nos.13456, 13458 and 13462/2025 are filed by the petitioners / appellants to condone the delay of 5591 days in filing the petition to set aside the abatement caused due to the death of the 3rd respondent ; to set aside abatement and to bring on record the proposed respondents 5 and 6 / LRs of the deceased 3rd respondent as respondents 5 and 6 in the above Second Appeal.

- (2) CMP.Nos.13475, 13479 and 13482/2025 are filed by the petitioners / appellants to condone the delay of 3192 days in filing the petition to set aside the abatement caused due to the death of the 4th respondent ; to set aside abatement and to bring on record the proposed 7th respondent / LR of the deceased 4th respondent as the 7th respondent in the above Second Appeal.
- (3) The relationship between the parties is not disputed. Being satisfied with the reasons stated in the respective affidavits filed in support of CMP.Nos.13456 and 13475/2025, the delay of 5591 days and 3192 days is **condoned and the petitions are ordered.**
- (4) Consequently, CMP.Nos.1348, 13462, 13479 and 13482/2025 are also **ordered.**
- (5) Registry is directed to carry out necessary amendment in the cause title.

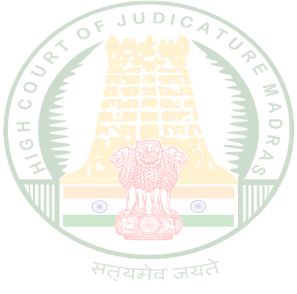

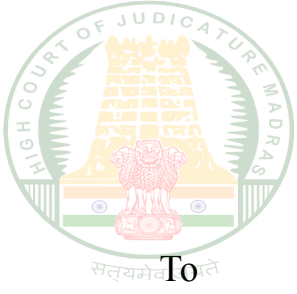
