ORDER

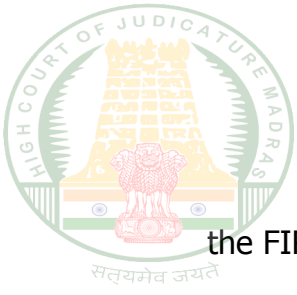

2. Learned counsel for the petitioner submitted that the dispute in this case is civil in nature.
