Alleging that the petitioner's daughter, K.Santhiya, aged about 18 years, is in the illegal custody of the third respondent, the present Habeas Corpus Petition has been filed.

2. Today, the respondent police had produced the petitioner's daughter along with the third respondent before us. When we interacted with the petitioner's daughter, she disclosed that she had married the third respondent herein on 06.05.2025 and is presently living with him. She also expressed her intention to continue living with him. Since the petitioner's daughter was born on 18.06.2006 and is a major, having taken a conscious decision to marry a person of her choice and reside with him, this Court, while exercising powers under Article 226 of the Constitution of India, finds no
