2. Considering the submissions made and upon perusal of the records, this Court is of the opinion that the petitioner is entitled to withdraw the said amount.

3. Accordingly, this Criminal Miscellaneous Petition is allowed. The petitioner is permitted to withdraw the amount, which was deposited by the respondent, in view of the direction issued by this Court while suspending the sentence. It is made clear that the Trial Court is directed to permit the petitioner to withdraw the amount, without ordering notice to the respondent herein, upon proper identification and verification.
