2. As there has been no progress in the matter and the writ petition has remained pending for a considerable period, the present writ petition is dismissed for non-prosecution. No costs.

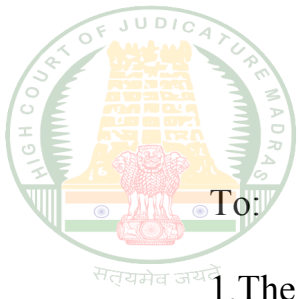
