ORDER

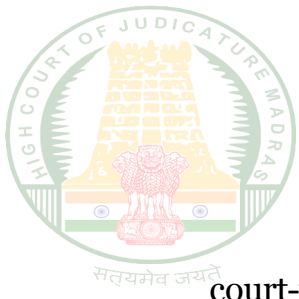
(Order of the Court was made by the Hon'ble Chief Justice)
