ORDER

The writ petition has been filed to direct the respondents to consider the petitioner's representation dated 30.05.2025 and thereby direct the respondents to reinstate the petitioner into service from 14.02.2025 with all consequential monetary and other service benefits.

2. The case of the petitioner is that, he was suspended from service vide order dated 14.02.2025. Aggrieved by the same, he sent a representation dated 30.05.2025 for revocation of suspension and the said representation is yet to be considered by the respondents.

3. Mr.C.Jayaprakash, learned Government Advocate, who takes notice for the respondents would strongly object the petitioner's contention and would submit that the petitioner was remanded to judicial custody on account of the complaint given by girl student. Therefore, suspension order was issued against the petitioner. However, he would fairly submit that the representation of the petitioner would be considered within a reasonable time.

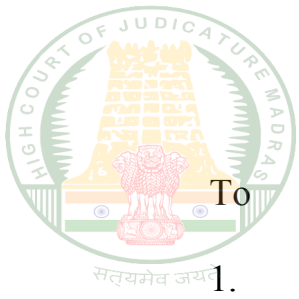
In the result, the Writ Petition is disposed of with the above direction. No costs.
