Writ, Order or Direction particularly in the nature of Writ of Declaration, declaring that the land acquisition proceedings in respect of Survey No.102/2 measuring an extent of 1 acre and 96 cents at Ayyamperumalpatti, Salem being the subject matter of the Land Acquisition Proceedings pursuant to the Notification 4(1) of the Land Acquisition Act, 1894 in G.O.Ms.No.755 Housing and Urban Development Department dated 04.09.1981 and the Declaration under section 6 of the said Act in G.O.Ms.No.18 Housing and Urban Development Department dated 04.01.1983, is having lapsed under section 24 (2) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and pass such further or other orders as this Hon'ble Court may deem fit and proper in the circumstances of the case and thus render justice.
