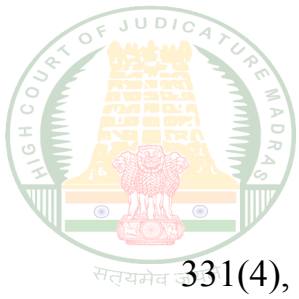
PRAYER : Criminal Original Petition filed under Section 483 of Bharatiya Nagarik Suraksha Sanhita, 2023, to enlarge the petitioner on bail in Crime No.128 of 2025 pending investigation on the file of the respondent police station.

ORDER

The petitioner, who was arrested and remanded to judicial custody on 21.05.2025, for the offences punishable under Sections 333, 296(b),



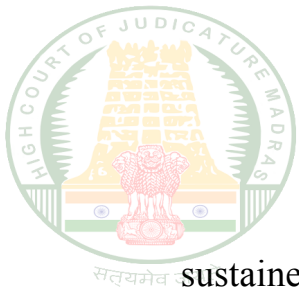

331(4), 118(1), 109(1) and 351(3) of BNS, 2023 (452, 294(b), 457, 324, 307 and 506(ii) of IPC) in connection with Crime No.128 of 2025, registered on the file of the respondent, seeks bail.

2. The case of the prosecution is that the petitioner trespassed into the house of the de-facto complainant and attacked him with knife and escaped from the place, thereby the de-facto complainant sustained cut injury and admitted in the hospital. Hence, the case.

3. The learned counsel for the petitioner submitted that the petitioner is an innocent person. During village festival, some dispute arose between the petitioner's family and de-facto complainant's family. Hence, the petitioner has been falsely implicated in this case. He further submitted that the injured has been discharged from the hospital on 02.06.2025 and he prays to grant bail to the petitioner.

4. Learned Government Advocate (Criminal Side) appearing for the respondent police, while opposing for grant of bail to the petitioner, reiterated the prosecution case and submitted that the de-facto complainant

sustained deep cut injury on his finger and admitted in the Namakkal Government Hospital on 21.05.2025 and discharged from the hospital on 02.06.2025.

5. Heard both sides and perused the materials available on record.

6. Considering the submissions made by the learned counsels on either side, the period of incarceration undergone by the petitioner and the injured has been discharged from the hospital, this Court is inclined to grant bail to the petitioner with certain conditions.

7. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.10,000/- (Rupees Ten Thousand only)** with **two sureties**, each for a like sum to the satisfaction of the learned **Judicial Magistrate, Sendamangalam, Namakkal District**, and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a

copy of any one of the identity proofs to ensure their identity;

[b] the petitioner shall report before the respondent Police everyday at 10.30 a.m., until further orders;

[c] the petitioner shall make himself available for interrogation by a Police Officer as and when required;

[d] the petitioner shall not directly or indirectly cause any threat to the de-facto complainant and witnesses;

[e] the petitioner to give an undertaking that if required for being identified by witnesses during investigation or for police custody beyond the first fifteen days, he shall comply to the directions as may be given by the Court in this regard;

[f] On breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to pass appropriate orders against the petitioner in accordance with law as if the aforementioned conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)13 SCC 283]**;

[g] If the accused thereafter absconds, a fresh
FIR can be registered under Section 269 of B.N.S.
