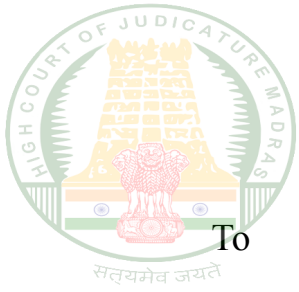
2. Pursuant to the aforementioned proceedings, captioned matter is listed today under the cause list caption 'FOR DISMISSAL'
