3. The learned XIII Metroplitan Magistrate, Egmore shall do well to pass further orders in accordance with law on the final report at the earliest.

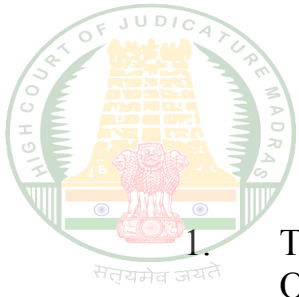
4. In view of the above, the writ petition Criminal stands disposed of. Consequently, connected miscellaneous petition is closed.
