ORDER

The instant writ petition has been filed with a prayer for issuing a Mandamus, to direct the respondent to settle a sum of Rs.4,02,390/- towards 6% interest for the belated settlement of Terminal Benefits to the petitioner herein by considering the representation of the petitioner dated 07.05.2025.

2. The case of the petitioner is that the petitioner has joined in the respondent Corporation on 01.07.1998 and had retired from his service on 30.06.2023. However, the terminal benefits have been settled to him only on 16.04.2025 and no interest has been paid to them for the delayed period. In view of the same, the petitioner has submitted a representation dated 07.05.2025 to the respondent to pay interest for the delayed period. Since the same was not considered by the respondent, the present writ petition has been filed by the petitioner.

3. At this juncture, the learned Standing Counsel appearing on behalf of the respondent would fairly submit that they would consider the said representation of the petitioner dated 07.05.2025 and pass order within a

reasonable time.

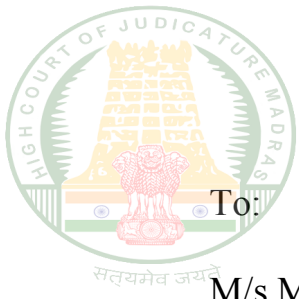
4. Heard the learned counsel on either sides and perused the materials available on record.
