**ORDER**

This writ petition has been filed by the petitioner seeking to forbear the respondents 1 to 3 from shifting the shop No.2238 from the existing building bearing door No.2/337-A (Shop) and 2/337-B (bar) of SF No.159/1 in Kalampalayam, Theethipalayam Village, Siruvani Main Road, Coimbatore-641 010.

2.Mr.K.Sathish Kumar, learned Standing Counsel takes notice on behalf of the respondents 1 to 3. By consent of the parties, the main writ petition is taken up for disposal at the admission stage itself.

3.Learned counsel for the petitioner would submit that the respondents 4 to 7 lodged a false complaint to the respondents 1 to 3 stating that the TASMACH shop run by the petitioner cause nuisance to the public and the complainant's



property. Therefore, the petitioner apprehend that the petitioner's shop would be shifted to some other place, which is cause irreparable loss to the petitioner.

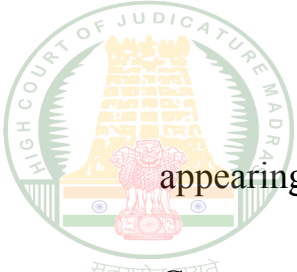
Hence, the present writ petition has been filed.
