2. The learned counsel for the petitioner states that the respondent-husband has filed O.P. No.118 of 2024, which is pending on the file of the Subordinate Court, Tindivanam and whereas the petitioner-wife has filed M.C. No.19 of 2025 before the Family Court, Cuddalore.

3. The petitioner who is a resident of Cuddalore, expresses inconvenience to attend the proceedings before the Sub Court, Tindivanam and also considering that the connected proceeding in M.C. No.19 of 2025 is pending before the Family Court, Cuddalore, has sought for transfer of O.P. No.118 of 2024 to be jointly tried along with M.C. No.19 of 2025.
