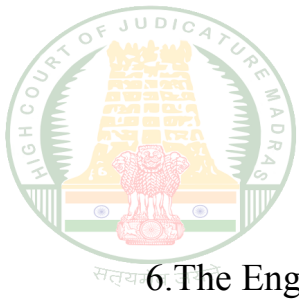

3. At the outset, it is submitted by Mr.A.Selvendran, learned Special Government Pleader for respondents that they would deposit the sum of Rs.35,56,282/- together with interest within a time frame to be fixed by this Court. Agreed to by the learned counsel for petitioner.

In view thereof, the writ petition stands disposed of with a direction to the respondents to deposit the balance amount of Rs.35,56,282/- together with interest to the credit of LAOP No.1443/2008 on the file of Sub-Court, Kancheepuram within a period of 8 weeks from the date of uploading of a copy of this order without waiting for receipt of certified copy. No costs.
