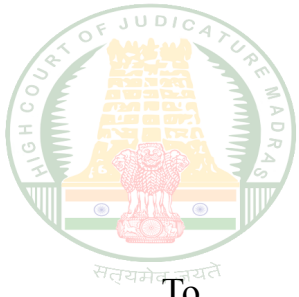
COMMON ORDER
