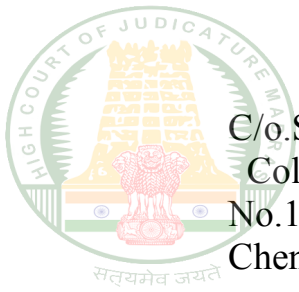

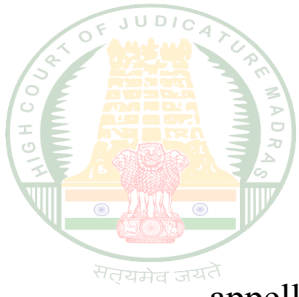

Challenge in this appeal is to the order of the learned single Judge made in W.P.No.20193 of 2025 dated 05.06.2025.

2. Learned counsel for the appellant would submit that though the order dated 10.06.2025 reads as if he was heard, he was not factually heard. This is an imputation against the learned single Judge. We do not think we can go into the correctness of what is recorded in the order of the Court.

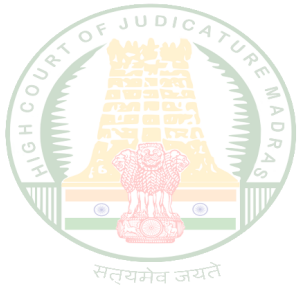
