2. Recording the submission of the learned counsel appearing for the petitioner, this Writ Miscellaneous Petition is dismissed as withdrawn. No costs.

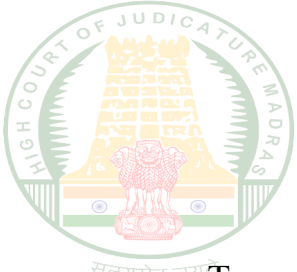
