Government on 14.06.2025.

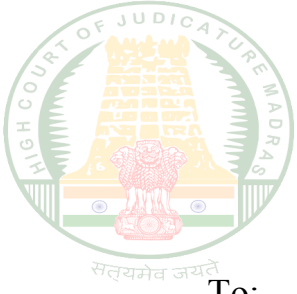
