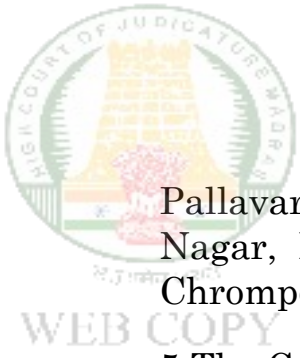

ORDER

In view of the same, it will suffice if a direction is given to the 2nd respondent to deal with the appeal, on its own merits and in accordance with law, after affording opportunity to all the parties concerned and pass final orders, within a period of eight weeks from the date of receipt of a copy of this order.
