3. As a corollary, Registry is directed to number the suit.

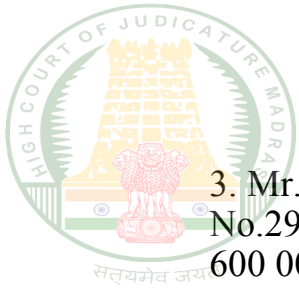
