Today, when the matter is taken up for consideration, Mr.Vasanthakumar, learned Additional Government Pleader (Puducherry) appearing for the respondents submitted that the petitioner had already made an application before the Settlement Officer for deleting the name of the temple and after considering the request and after conducting due enquiry, final orders have been passed by the Settlement Officer on 09.10.2025.
