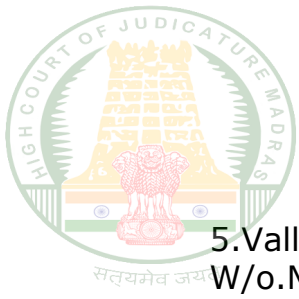

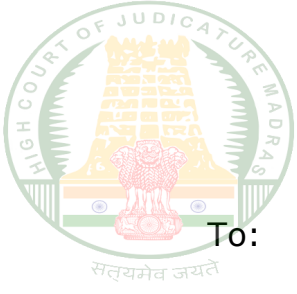
4. Placing on record the statement made by learned State counsel, this petition is disposed of as infructuous. There shall be no order as to costs.
