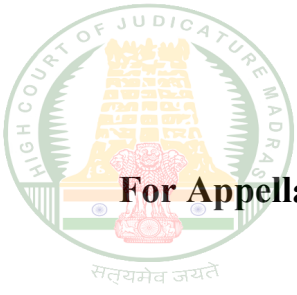

ORDER

This petition has been filed seeking to condone the delay of 372 days in filing the appeal.

2. Heard the learned counsel appearing for the petitioner and Mrs. Rathna Thara, learned counsel who takes notice on behalf of the second respondent. The learned counsel appearing for the petitioner submits that the first respondent remained exparte before the tribunal and hence, notice to the first respondent may be dispensed with and also made endorsement to that effect.
