The learned counsel appearing for the petitioner seeks permission of this Court to withdraw this petition. He has also made an endorsement in the Court bundle, today, to that effect.

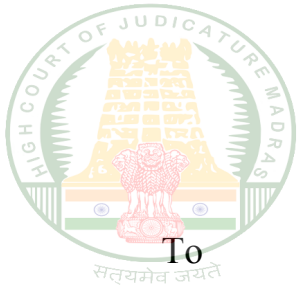
2. In view of the endorsement made by the learned counsel for the petitioner, this Criminal Original Petition is dismissed as withdrawn.
