Nos.22226 and 22244 of 2015, this Court by order dated 24.06.2025 directed the petitioners to deposit the penalty amount and on such deposit, directed the respondents to give all the certificates. As such, they are ready to deposit the penalty Rs.25,000/- in W.P. No.22232 of 2025, Rs.25,000/- in W.P. No.22235 of 2025 and Rs.10,000/- in W.P. No.22249 of 2025 subject to the outcome of these writ petitions.

3. With the above observations, these Miscellaneous Petitions are allowed.
