No criminal offence is made out as against the accused persons. The petitioner is trying to get the help of the respondent Police by way of obtaining a direction on the petitioner's representation, and also seeking indulgence of this Court. This Court is not inclined grant the relief sought for by the petitioner in this petition.

5. In view of the same, this Writ Petition is dismissed. There shall be no order as to costs. However, the petitioner is at liberty to work out his remedy in the manner known to law.
