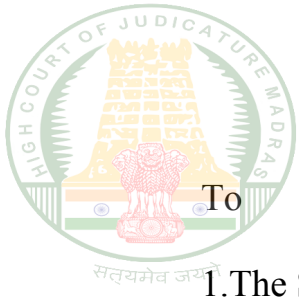
2. Considering the request coupled with the endorsement made by the learned counsel for the petitioner, this writ petition is dismissed as withdrawn. No costs.
