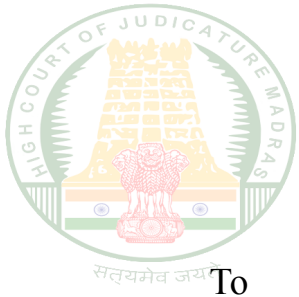
4. This Court makes it clear that we would be giving a closure to the
