PRAYER

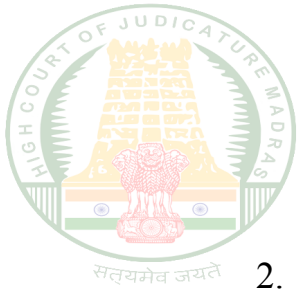
