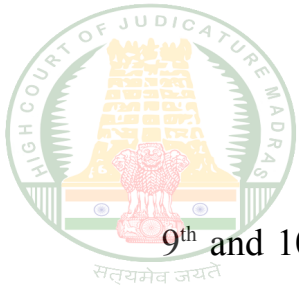

3. Without expressing any opinion on the merits of the writ petition, the



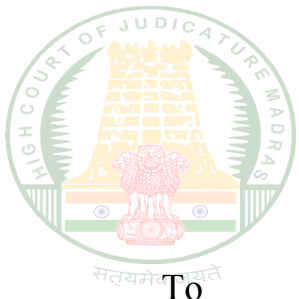
