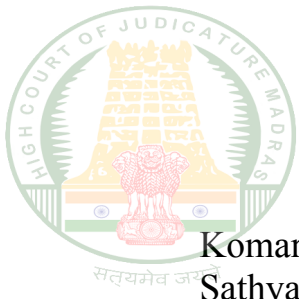

When the matter was taken up for hearing on 25.02.2025, this Court

passed the following order:

“This Court vide its order dated 06.01.2025 directed the Registry to issue notice to the petitioners, since the counsel on record for the petitioners have withdrawn the vakalat.

2. In compliance of the aforesaid order dated 06.01.2025, the Registry has issued a notice to the petitioners, wherein, the petitioners 1 & 2 have received the same and in regard to third petitioner, the endorsement says “Tapal due - Not ready”.

3. In view of the above Registry is directed to issue notice to the third petitioner.

4. List the case on 13.03.2025 under the caption “For dismissal”.”
