ORDER

When the matter was taken up for hearing today, the learned Government Advocate (Crl.Side) appearing for the respondents-Police, on instructions, submitted that investigation in Crime No.21 of 2024 is over and final report has already been filed before the Judicial Magistrate No.I, Krishnagiri and the same was taken on file in C.C.No.415 of 2024.
