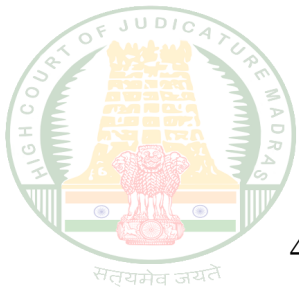

6. However, the respondent police is directed to expedite the investigation and file the charge sheet within a period of two months from the date of receipt of a copy of this order.

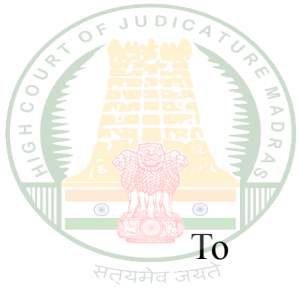
