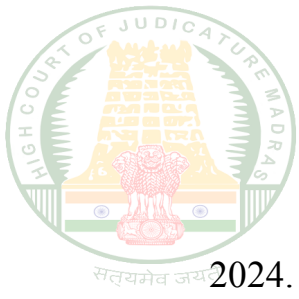

ORDER

The present application has been filed to modify the order dated 21.04.2025 in C.S.No.41 of 2024 and expressly grant liberty to the plaintiff to file a fresh suit in respect of the same cause of action and reliefs.

2. This Court had passed a judgment on 21.04.2025 in C.S.No.41 of 2024.
