ORDER

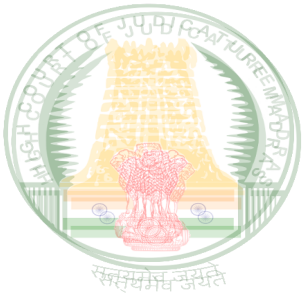

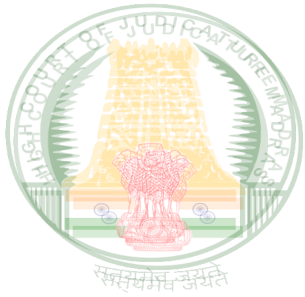
