3. The petitioner is the wife who seeks transfer of HMOP.No.51 of 2023 pending on the file of the Sub Court, Paramathi Velur, Namakkal to the file of the Subordinate Court, Alandur.

The learned counsel for the respondent states that the respondent husband has no serious objections for the transfer petition being allowed, since there is a connected matter pending before the learned Subordinate Judge, Alandur and has also seeks for expeditious disposal of the two HMOP.Nos.51 of 2023 and 194 of 2023.
