3. Recording the submission made by the learned Government Advocate (Crl.Side), this Criminal Original Petition is dismissed.

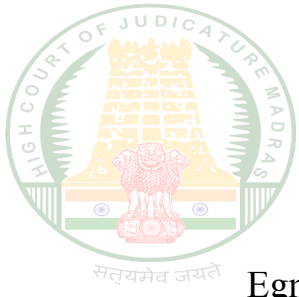
